- 1. At 6:30 p.m., a Work Session was held for the City Council to view the Peirce Island Video.
- 2. <u>Proclamation International Alpha Delta Kappa Month</u> Councilor Grasso on behalf of Mayor Sirrell read a Proclamation declaring October as International Alpha Delta Kappa Month.
- 3. <u>Presentation Arcadia Publishing Representatives presenting Mayor Sirrell with a book on</u> <u>Portsmouth Then and Now – Amy Sutton and Stephanie Elliott</u> – Amy Sutton presented Mayor Sirrell with a book written by Bill and Connie Warren on Portsmouth Then and Now. Bill and Connie said that they enjoyed creating this book and sharing their photographs of Portsmouth Then and Now.

- 14. <u>Request for Payment in Lieu of Taxes (PILOT) from Great Bay Services</u> Voted to accept \$10.00 as a PILOT from Great Bay Services.
- 15. <u>Request for Approval of Pole License Agreements</u> Voted to approve the pole license agreements as recommended by the Public Works Department.
- 16. <u>Letter from Mark Syracusa to erect a memorial at the intersection of Court Street and Middle</u> <u>Street (Not on agenda)</u> – Voted to accept and place the letter on file.
- 17. <u>Appointments</u> The City Council considered the reappointment of Ellen Fineberg to the Historic District Commission. This appointment will be voted on by the City Council at the November 19, 2001 City Council meeting.

Voted to reappoint Virginia Weeks as an alternate to the Zoning Board of Adjustment until December 1, 2006.
