# PORTSMOUTH TAXI COMMISSION

Minutes of the December 16, 2002 meeting

#### I. CALL TO ORDER

Chair Sanford called the meeting to order at 9:07 a.m.

#### II. ATTENDANCE

<u>Members and Ex-Officio's Present</u>: Chair Sanford, Members Daggett, Bresciano, Feehley, Councilor Whitehouse, and City Clerk Barnaby.

## III. ACCEPTANCE OF MINUTES – NOVEMBER 18, 2002

Councilor Whitehouse moved to accept the minutes of the November 18, 2002 meeting. Seconded by Frank Daggett and voted.

### IV. NEW BUSINESS

#### 1. New Year's Eve

Chair Sanford asked if any taxi companies would be operating passenger vans during New Year's Eve for a fee of \$5.00 as was done last year.

Lisa Crowell of Pioneer Taxi said that she has a passenger van that she would like to use on New Year's Eve.

Frank Daggett moved to allow Pioneer Taxi to operate a passenger van on New Year's Eve with a flat free for fares of \$5.00. Seconded by James Feehley and voted.

Frank Daggett requested that Pioneer Taxi provide the City Clerk with an insurance policy covering the passenger van that would be used during New Year's Eve.

Chair Sanford asked how many taxis Blue Star would be operating on New Year's Eve. Mr. Feehley responded that Blue Star would be operating 5 vehicles as long as business was available on New Year's Eve.

# 1.A. Taxi Commission holiday schedule (not on agenda)

### 2. New Taxi Stand Location

Councilor Whitehouse said that the new stands would be operational after the first of the year. He advised the Commission that the Public Works Department is very busy this time of year and would post the signs after the first of the year.
