1. Review of Minutes

a. Overnight Art

b. Outreach

- i. Russ Grazier reported that phase two of the Artworks project is just about to start. Bill Hurley at Infinite Imaging has agreed to host the closing reception for the exhibition at his new location on Islington Street. Reception is tentatively scheduled for Wednesday, May 26.
- **ii.** Russ also reported that Youth Art Month is happening this month and Art-Speak coordinated more than 35 pieces of student art hanging in downtown businesses.

c. Public Art

- i. Jane James reported that the public art committee met because the city has received a request for a donation of a piece of art to Pierce Island.
- **ii.** Jane also reported that the Percent for Art funds allocated for Fire Station II were rescinded by the City Council.

5. Constituency Building
