

Dear Mr. Loughlin:

We are submitting this request for a review of the above-referenced shrubbery, to obtain approval to have them removed for public safety reasons. These now-overgrown landscape plantings shield the Rock Street Park from the view of neighbors and officers on cruiser patrol in the area around the park.

We have enclosed both aerial and ground-level views of the location for your review. As you can see, the combination of parked cars and overgrown shrubs obscures a clear view of what is going on in the park for the officers. This condition creates quite a dark wall at night which masks unlawful activities. We respectfully request this item be placed on the agenda for the October 6<sup>th</sup> meeting of the Trees & Public Greenery Blue Ribbon Committee. We are requesting the go-ahead to arrange for removal of the trees, so that this work may be accomplished before we lose the good weather.
