Acceptance of Grants/Donations:

1. <u>Grant Application for African Burying Ground.</u> The African Burying Ground Committee has identified the Rosamond Thaxter Foundation as a potential funding source for the construction of the African Burying Ground Memorial Park - We Stand in Honor of Those Forgotten. The grant amount is up to \$5,000. The Foundation requires that the City Council approve the funding request prior to submission.

I would recommend the City Council authorize the City Manager to apply for, accept and expend a grant of up to \$5,000 from the Rosamond Thaxter Foundation for the construction of the African Burying Ground Memorial Park - We Stand in Honor of Those Forgotten. Action on this item should take place under Section VII of the Agenda.

2. <u>Acceptance of Donation to the Coalition Legal Fund.</u> Attached is a copy of a check from the Town of Tuftonboro in the amount of \$5,000.00 donating funds to the Coalition Legal Fund, which will be utilized to continue our fight to eliminate the statewide property tax.

I would recommend the City Council move to approve and accept the donation, as listed, to be placed in the Coalition Legal Fund. Action on this matter should take place under Section VII of the Agenda.

 - 1.1 First reading of Ordinance Amending Chapter 10, Article 4, Section 10.421.10 –District Location and Boundaries of the zoning ordinance of the City of Portsmouth and the City of Portsmouth Zoning Map be amended by rezoning the property located off Bartlett Street/Cate Street at Assessors Map 165, Lot 1 from Industrial (I) to Business B) District. At the City Council meeting on September 6, 2011, the Council voted to accept the Planning Board's rezoning recommendation as presented in Planning Director Rick Taintor's memorandum dated August 24, 2011 and to bring back for first reading a zoning amendment to reflect this proposed change at the September 19, 2011 City Council meeting. As outlined in Mr. Taintor's attached memo, the proposed zoning amendment would result in the rezoning of land at 30 Cate Street (Map 165, Lot 1) from Industrial (I) to Business (B). Also, attached is a proposed Ordinance to implement the recommended Zoning Map amendment and an exhibit illustrating the zoning district change.

I would recommend that the City Council move to pass first reading and schedule a public hearing and second reading on the proposed Ordinance, as presented at the October 3, 2011 City Council meeting. Action on this item should take place under Section VIII of the Agenda.

Consent Agenda:

1. Request for a License from Philip T. McLaughlin, owner of McLaughlin Law Offices for property located at 75 Court Street to install a projecting sign. Attached under Section IX of the Agenda is a request from Philip T. McLaughlin, owner of McLaughlin Law Offices for property located at 75 Court Street for a Projecting Sign License (see memorandum from Rick Taintor, Planning Director).

I would recommend the City Council move to approve the aforementioned Projecting Sign License as recommended by the Planning Director and, further, authorize the City Manager to execute a License Agreement for this request. Action on this matter should take place under Section IX of the Agenda.

City Manager's Items Which Require Action:

1. Proposed Agreement between the Police Commission and the Police Patrolman's Union, NEPBA Local #11. The Police Commission has approved a Tentative Agreement with the Portsmouth Patrolman's Association to expire on June 30, 2014. I am forwarding the Tentative Agreement to the City Council for action.

The Portsmouth Patrolman's Association reached a Tentative Agreement on June 28, 2011. I have attached the following documents for your review:

- A letter from Thomas Flygare, City Negotiator outlining the changes to the contract
- A copy of the contract showing the insertions and deletions to implement the Tentative Agreement if approved.
- Various Cost Analyses.

Action is required on this matter.

2. **Proposed Agreement Re: Senior Transportation.** As discussed at the September 12th City Council Work Session, attached is a proposed Agreement between the City of Portsmouth and the Mark Wentworth Home d/b/a Wentworth Connections to provide transportation for senior citizens. Also, attached is the summary of the presentation that was provided at the September 12th Work Session which outlines the history and the funding requirements for this program. I am requesting that you approve this proposed Agreement.

I would recommend the City Council move to authorize the City Manager to enter into an Agreement between the Mark Wentworth Home d/b/a Wentworth Connections and the City of Portsmouth from July 1, 2011 through June 30, 2012.

3. Establish Public Hearing Re: Supplemental Appropriation for Indoor Pool for FY12. As was discussed at the September 12th City Council Work Session, the City Council may establish a public hearing for Monday, October 3, 2011 for the purpose of acting on a proposed supplemental appropriation for FY12 in order to fund the operation of the indoor pool for FY12 (July 1, 2011 through June 30, 2012). In order to maintain the operation of the indoor pool through a public/private partnership with Save the Indoor Portsmouth Pool (SIPP), a non-profit, the proposed amount of this supplemental appropriation is \$150,000 for FY12. I am recommending that this appropriation come from the City's fund balance. Attached is the presentation which was provided at Monday's September 12th Work Session. As you are aware, this proposed supplemental appropriation is the first step in a five-year commitment to fund the pool through this public/private partnership in which the City will provide supplemental funds for the operation and SIPP will provide funds for capital improvements.

I would recommend the City Council move to establish a public hearing for Monday, October 3, 2011 for the purpose of a supplemental appropriation of \$150,000 for the operation of the indoor pool for FY12.

4. Request to Accept Sewer Easement off of Spring Street. As part of the Lincoln Avenue Sewer Separation Project, the City was required to obtain an easement to place a portion of the public sewer on the property of Mr. & Mrs. Getman on the southside of Spring Street (see attached easement work plan). A portion of the public sewer/drain line already extended onto the Getman's property prior to the Sewer Separation Project, but there was no earlier deed for that minor encroachment. The proposed easement deed encompasses the newly constructed sewer line and releases any claim the City might have had to continue to use the older sewer/drain line.

I would recommend the City Council move to authorize the City Manager to accept a Sewer Easement from Frank W. Getman, Jr. and Ingrid C. Getman.
