I. CALL TO ORDER: The chairman called the August 17th, 2011 monthly police commission public session to order at 5:02 p.m.

Action: Commissioner Golumb moved to go into non-public session for the purpose of discussing personnel issues as per RSA 91-A:3, II.

On a Roll Call Vote: The board voted unanimously to go into non-public session at 5:02 p.m.

Action: Commissioner Russo moved to come out of non-public session. Seconded by Commissioner Golumb.

On a Roll Call Vote: The board voted unanimously to come out of non-public session at 5:56 p.m.

Chairman Howe called the public session back to order at 6:03 p.m. in the Eileen Dondero Foley Council Chambers of Portsmouth City Hall.

Officer Houde and the Explorer Cadets presented the Commission with the New Hampshire Law Enforcement Weekend Challenge First Place trophy won by the Cadets earlier this year, as well as the third place trophy in the "Best Overall" category they garnered at the Massachusetts games in May.

The Commissioners individually commended the cadets and the value of the overall program.

A. POLICE COMMISSION:

1. Personnel Items that require action:

Action: Commissioner Golumb moved to appoint Officer Scott Pearl to Master Patrol Officer status.

Seconded by Commissioner Russo.

On a Roll Call Vote: The board voted unanimously to appoint Officer Scott Pearl to Master Patrol Officer status, effective July 30th, his ten-year anniversary date.

Action: Commissioner Golumb moved to accept the resignation of Auxiliary Officer Wm. Irving.

Seconded by Commissioner Russo.

On a Roll Call Vote: The board voted unanimously to accept the resignation of Officer Irving.

- **B. CHIEF OF POLICE:** In Chief Ferland's absence, Deputy Chief DuBois conducted this portion of the briefing.
 - **1. Deputy DuBois recognized Dispatcher Keith Noseworthy** for his actions early last month in Farmington that helped save the life of a driver trapped in his burning vehicle after a motor vehicle accident by reading Keith's recognition letter into the record.
 - 2. Item 2 was addressed earlier in the meeting.

The Deputy continued with the following updates:

- Pease Air Show. The air show was a large, successful event. Of particular note is the logistical and planning work of Lt. Maloney and Sgt. Keaveny to deal with moving tens of thousands of cars in and out of the air show without encountering the traffic woes of last year. They successfully moved 50,000 people in and out of the show pretty much without a hitch. They deserve a lot of credit for the work they put into this over the past year.
- Thefts from vehicles The Deputy explained he gets a monthly crime report from our crime analyst and every month sees many car break reports. There is a saying, "See something, Say something." Deputy DuBois urged the public to let the police know about any thing that appears suspicious to them, however small. We are happy to check things out; some of our best leads come from such calls, he said.
- National Night Out Portsmouth had another very successful event this year with good neighborhood participation. In a related topic, the Deputy reminded everyone that school will be starting August 31st this year, and he asked the public to again be alert for children in the crosswalks and on sidewalks. Deputy DuBois indicated we have obtained some grant monies and our officers would be doing some crosswalk/stop sign enforcement to raise driver awareness during the time period surrounding the opening of school.

In addition to the letter included in the meeting packet, Deputy DuBois relayed some formal and informal thank you's received by the Chief's office.

Action: Commissioner Golumb moved to accept a grant in the amount of \$234,318 from the Dept. of Juvenile Justice and Delinquency Prevention to continue funding of the New Hampshire Internet Crimes

Against Children Task Force (ICAC). The Commissioner noted that as the Task Force headquarters, Portsmouth will distribute the grant monies among the state's local ICAC affiliates.

Seconded by Commissioner Russo.

On a Roll Call Vote: The board voted unanimously to accept the grant and forward it on to the city council for their action.
