1. BUDGET WORKSHOP SESSION

Superintendent McDonough reviewed proposed cuts to Central Office personnel. Board members discussed the following topics:

- 1. How will Assistant Superintendent integrate technology into the curriculum and who will evaluate IT personnel?
- 2. How do some peer groups manage without a facilities manager?
- 3. Can we learn anything from private schools?

Mr. Zadravec reported on proposed changes to the Assistant Superintendent job description stating that the focus will primarily be with technology integrators, as well as Tom Lotz, to assure that the district is assembling the infrastructure necessary to support education.

Chair Shuldman asked the Assistant Superintendent if he could foresee the new responsibilities impacting the curriculum work he is already responsible for. Mr. Zadravec stated that student learning is already integrated with technology and is increasingly becoming a tool to help teachers become more efficient. Having Mr. Zadravec oversee technology integration in the classroom and curriculum only makes sense.

Mr. Bartlett reviewed the proposed personnel changes in maintenance and the facilities manager job description.

The model that the district has been operating under states that custodial supervisors report directly to building administrators and secondarily to Ken Linchey. By custodial supervisors now reporting directly to Mr. Linchey and secondarily to building principals, administrators and building principals will now have more time for staff and curriculum needs.

Superintendent McDonough provided an excerpt from school of approval minimum state standards and requested that board members review certain sections by the next regularly scheduled board meeting.
