I. OLD BUSINESS – SITE PLAN REVIEW

A. The application of **Service Credit Union, Owner**, for property located at **2995 Lafayette Road**, requesting Site Plan Approval to construct a $23,366 \pm s.f.$ (footprint) 4-story office building, with related paving, lighting, utilities, landscaping, drainage and associated site improvements. The application of **Richard Bonhomme Realty, LLC, Owner**, and **Chinburg Builders, Applicant**, for property located on Kearsarge Way, for Preliminary Subdivision Approval to consolidate Lots 118, 119 and 122 as shown on Assessor Map 212, totaling 227,623 s.f. (5.2255 acres), and subdividing the lot into 21 individual lots varying in size from 5,007 s.f. to 14,002 s.f. Said lots lie within the General Residence B (GRB) District. Said property is shown on Assessor Plan 254 as Lot 8 and lies within the Municipal district;
