The Commission voted to recommend approval of the application to the Planning Board as presented with the following stipulations:

- 1) That the applicants increase the size of each of the blueberry bushes to be installed and specified in their planting plan from a 1 gallon size to a 3 or 5 gallon size.
- 2) That the applicant provide monitoring reports for the site, which include photographs of the site, a report of the site detailing the success of the plantings and any other pertinent details about the success of the proposed restoration plan. A minimum of five (5) monitoring reports will be provided to the Planning Department to the attention of the Environmental Planner: on or before November 15, 2012; May 15, 2013; August 30, 2013; May 15, 2014; and August 30, 2014. In each report, starting with the May 15, 2013 report, the applicant must demonstrate 80% success of all the plantings or propose and install additional plantings to achieve an 80% survival of all species. The report submitted in August 2014 will be reviewed by the Conservation Commission at which time the Commission will determine if the restoration has been successful and no further work or reporting is necessary or if additional work and reporting is necessary to restore the site.
- Banfield Road ROW, Heritage Avenue to Peverly Hill Road City of Portsmouth, owner Unitil, applicant Assessor Map ROW, Lot ROW

The Commission voted to recommend approval of the application to the Planning Board as presented with the following stipulation:

1) That a silt sock or other non-ground disturbing siltation technology is used to avoid unnecessary siltation impacts.
