  - b. FY15 BUDGET ADJUSTMENTS Mr. Bartlett provided an updated budget overview.

SPECIAL EDUCATION Ms. Simons shared a PowerPoint of the Special Ed FY2014-15 budget, highlighting increasing numbers of ESOL students, homeless students, and shared cost students (where transportation costs are split). Ms. Simons publicly thanked several companies and organizations who adopted a number of families over the holidays, making a difference in many students' lives. Board members followed up with questions including shared costs students and how costs are determined between districts, the responsibilities of a district's homeless liaison, decreasing tuition revenue and the reasons for it, and finally staffing levels and how Ms. Simons determines staff assignments based upon students' needs. Medicaid reimbursement remains high due to staff diligence in making sure all services are written within a student's IEP. The district is now reporting and tracking all Medicaid reimbursements on line. Board members concluded with reviewing how a student is identified and an IEP is determined.
