1. On a roll call 7-1, **voted** to enter into an Anticipated "Non-Meeting" regarding City Manager's Evaluation in Accordance with RSA 91-A:2, I (b). Councilors Kennedy, Lown, Dwyer, Morgan, Spear, Thorsen and Mayor Lister voted in favor. Assistant Mayor Splaine voted opposed. Councilor Shaheen was not present for this vote.

- 2. Presentation Click N' Fix Program Public Works Director Rice provided a brief presentation to introduce the new Portsmouth Click N' Fix Program. He stated this is an added way for residents to communicate with the Department of Public Works and allows residents to report issues and request services through online and mobile applications. The program provides a direct link to the Departments work order management system and added metrics to measure levels of service per various Public Works' activities.
