However, no City Councilor including the Mayor shall be compensated for more than Twenty-Two (22) meetings during any calendar year.

Voted to place the proposed Charter Amendment #1 Compensation of City Councilors on the November 5, 2019 ballot.

- Public Hearing on Amendment E Police Department (Police Commission) <u>Appointment/Election Terms</u> – Held a public hearing. Voted to place the proposed Charter Amendment #2 Police Commission Vacancies on the November 5, 2019 ballot.
- 15. <u>First Reading of Ordinance Amending Chapter 7 Parking Omnibus</u> Voted to pass first reading of the annual omnibus set of ordinances recommended by the Parking and Traffic Safety Committee, and schedule second reading and public hearing for the July 15, 2019 City Council meeting.
