- 14. <u>Establish Sister City Mayor's Blue Ribbon Committee</u> <u>Voted</u> to accept and endorse the establishment and appointments of Stephanie Seacord, Valerie Rochon, Steve Zadravec, Tammi Truax and Steve Butzel, to the Sister City Mayor's Blue Ribbon Committee.
- 15. <u>Sister Cities International Friendship Agreement</u> <u>Voted</u> to authorize Mayor Blalock and the City of Portsmouth to enter into a Sister City Friendship Agreement with the City of Santarcangelo di Romagna, Italy)

- 16. <u>Safe Water Advisory Group</u> Assistant Mayor Lazenby and Councilor Pearson explained that they would like to recommend that the next Mayor and City Council endorse the formation of an advisory group related to Safe Drinking Water due to PFAS contamination issues. No Action taken.
- 17. Parking and Traffic Safety Committee Action Sheets and Minutes of the September 5, 2019 and October 3, 2019 meetings **Voted** to accept and approve the action sheets and minutes of the September 5, 2019 and October 3, 2019 Parking and Traffic Safety Committee meetings.

- Any removal or relocation of projecting sign, for any reason, shall be done at no cost to the City; and
- Any disturbance of a sidewalk, street or other public infrastructure resulting from the installation, relocation or removal of the projecting sign, for any reason shall be restored at no cost to the City and shall be subject to review and acceptance by the Department of Public Works

- 28. <u>Letter from Eric Chinburg, Chinburg Properties, requesting a fee waiver of building permit fees, water hookup fees and any impact fees for renovations of Carey Cottage Councilor Denton recused himself from the discussion and vote and stepped down from the dais. **Voted** to waive fees as requested.</u>
- 29. <u>Letter from Guy A. Pronesti requesting permission to remove sidewalk in front of 100 Pinehurst Road</u>— <u>Voted</u> that the City Manager be authorized to work with the property owners to remove sidewalks at owner's expense.
