- 1. Prior to the demolition, the applicant shall provide a written and pictorial record of the buildings history and architectural features to be accepted by the Portsmouth Planning Department, Portsmouth Advocates, and the Portsmouth Athenaeum. The report shall be prepared by an architectural historian certified under state law and include a narrative accompanied by photographs, drawings, maps, and copies of original documents. In addition, the applicant shall allow the Portsmouth Advocates access to assist in the recording of the historic aspects of the property.
- **2.** The Committee recommends using an interpretive sign either on the property or in the City's right-of-way.
- 3. The applicant agrees to salvage any architecturally significant elements that would be a benefit to the Parish and wider community.

VI. ADJOURNMENT

At 7:18 p.m., it was moved, seconded, and passed by unanimous vote (5-0) to adjourn the meeting.
