READING OF MEETING MINUTES II.

EXECUTIVE DIRECTOR'S REPORT III.

Mr. Welch went over his report and explained that the Portsmouth Housing Authority has received a CHAP (Commitment to engage with Housing Assistance Payments), which is the next step in RAD conversion. He noted that due to Resident Services' efforts at engaging residents in COAST's community forums, COAST has plans to implement two new bus stops in 2020: one by Atlantic Heights and one at City Hall. He noted the newly implemented raised garden beds at Margeson and Feaster, which were started with help from Resident Services. Mr. Welch thanked all who were able to make it to the May 18th ribbon cutting of the Meadows Preschool.
