comments: I use you not to approve the motion to change Columbus Day to Indigenous Peoples Day, but rather to amend it as I set forth below for the following reasons.

- 1. The City Attorney has stated that since Columbus Day is a state holiday, the Council cannot change the name of the holiday without enabling legislation which does not exist.
- 2.Substituting Indigenous Peoples Day for Columbus Day would be inconsistent with the June 15,2000 Resolution declaring Portsmouth to be a Racial Justice Community which was cited by several Councilors at your last meeting. Among the commitments contained in the resolution was "Cooperating with others to improve equity and inclusion and be welcoming of diversity throughout our community."

I suggest that when the Council recognized Indigenous Peoples Day along with Columbus Day last fall its action was consistent with the concepts of inclusion and welcoming diversity in our community as set forth in the Resolution. However, eliminating Columbus Day is an act of exclusion rather than inclusion and also fails to recognize the diversity of opinion that exists in our community regarding this issue. As Mayor Becksted said eliminating Columbus Day will pit one group of people against another and he does not want this to happen. Diversity cuts both ways and the Council needs to understand this fact. However, amending the motion to state as the City Attorney suggested at your last meeting that Indigenous Peoples Day will be observed co -terminus with Columbus Day in the City of Portsmouth, creates a win-win situation for everyone, allows us to become educated about the need for diversity, does not violate state law, avoids pitting one group against another and is consistent with the intent of the June 15,2020 resolution.
