Working Group Updates:

Business Retention and Expansion Survey – Sean Clancy advised that the BR&E Survey team has been working with the UNH Survey Center and that a first draft of the survey is now available. Councilor Lombardi asked if the first draft could be shared with the entire EDC and this was agreed to. Sean Clancy will forward draft and relevant email exchange to full EDC within one week.

Land Use Committee (LUC) Liaison – Assistant Mayor Kelley advised that the LUC is focused on simplifying Accessory Dwelling Unit permitting process.

New/Other Business:

- Chamber President *Ben Van Camp* updated the EDC on the following:
 - o Tourism Season is in full swing:
 - o Hotels, Restaurants, and Retailers report positive results "good summer" to date
 - o Hotels report that larger corporate groups are booking meeting space mid-week

There were questions about mining data on tourists as well as finding specific spending by zip codes. This data is hard to get and expensive to purchase.

City Council Update:

- Counselor Lombardi advised that many spending requests have been approved by City Council:
 - o Prescott Park Master plan, phase I regarding coastal resiliency
 - o School Facilities and teacher compensation (CBA negotiations concluded)

Also, the City Council has agreed to schedule an ARPA funds work session in the near future
