#### III. NEW BUSINESS

## A. Executive Director's Report

Mr. Welch commended the Resident Services team for their work.

Mr. Welch summarized his report, including PHA's request for City of Portsmouth Community Development Block Grant funding, and explained a recent request by Torrington Properties for PHA to give counsel on how to certify workforce housing compliance for for-sale condominiums.

Commissioner Main asked when we find out if we get the CDBG funding requested. Mr. Welch replied that he is not sure of the exact timeline. His understanding is that their process will go on now through July and that we could know the outcome sometime between now and then.

## B. Resolution 2023-002: Proposed Project-Based Voucher Transfer at Connors Cottage

Mr. Welch presented Portsmouth Housing Authority Resolution 2023 - 002, seeking authorization for the PHA to absorb 20 Project-Based Vouchers from the New Hampshire Housing Finance Authority. These vouchers are provided by NHHFA to Connors Cottage under a contract that was put in place when Connors Cottage opened in 2003. Because these vouchers are from the New Hampshire Housing Finance Authority's voucher program, the PHA does not earn that administrative fee for managing these vouchers despite doing all of the administrative work to do so. The reason for absorbing these vouchers is that it allows the PHA to receive the Administrative Fee that is paid by HUD for each voucher, representing a total of \$24,000 in new

income to the PHA per year. Another reason for absorbing these vouchers is that it would reduce administrative burden on PHA staff.

Commissioner Main asked if any other partner, such as the PHA Housing Development Ltd., has to do anything in relation to this, to which Chair Ferrini said they do not.

Commissioner Rodenhizer asked if absorbing these vouchers would increase rent, to which Ms. Labrie said that it would not.

Commissioner Rodenhizer motioned to approve Resolution 2023-002: Proposed Project-Based Voucher Transfer at Connors Cottage. Commissioner Griffin seconded the motion.
