Mr. Welch summarized his report, including mention of the grant in the amount of \$25,000 from the Foundation for Seacoast Health that Resident Services Director Kelley Lesko applied for and won. The grant money will be used by the Resident Services team specifically to help address social isolation and related health outcomes of elderly individuals.

Mr. Welch also updated the board about the \$250,000 grant that we received from the Federal Home Loan Bank of Boston Helping House New England Program for the Ruth Lewin Griffin Education Incentive Program. Consultant Peter Roche wrote the grant application for this program which will provide additional rent subsidies to residents enrolling in higher education or certificate programs.

Mr. Welch also informed the Board that there is a City Council work session scheduled for January 12th to discuss the possible disposition of the Sherburne School. Mr. Welch will make a presentation regarding the importance of building workforce housing there.
