

**MEETING MINUTES OF THE PORTSMOUTH  
ECONOMIC DEVELOPMENT COMMISSION**

February 6, 2026 7:30 AM- 9:00 AM

*Chair Ward* brought the meeting to order at 7:30 am.

*Chair Ward* entertained a motion to accept the EDC meeting minutes from January 9, 2026. The motion was made by *Commissioner Watson* and seconded by *Commissioner Weidman*. The motion carried.

- *Chair Ward* welcomed *Councilor Blalock* and *Councilor Flynn* to their first EDC meeting.

*Chair Ward* explained that the EDC requests City Council updates which are relevant to the work of the EDC at each meeting.

*Councilors Blalock* and *Flynn* provided a brief update on City Council's discussion of childcare, the resident parking proposal, new construction within the Historic District, and the adoption City Council goals for this council session.

*Chair Ward* and *Vice Chair Lachance* led a far-ranging discussion based on the EDC's annual retreat conclusions and previous input from all commissioners with the goal of identifying new initiatives and subsequent working groups within the EDC.

*Chair Ward* outlined initial topics which evolved through deep discussion of critical economic development needs vis-à-vis the goals of the City Council.

The areas and related working groups that surfaced and will require greater consideration were:

- 1) The Future of Work – Infrastructure needs, Workforce needs, Smart City, Education (CTE)  
Initial Working Group: *Councilor Blalock, Vice Chair Lachance, Commissioner Cyr*
- 2) Parking & Transportation  
Initial Working Group: *Commissioner Weidman, Commissioner Clement, S. Clancy*
- 3) Arts, Culture, and Enrichment  
Initial Working Group: *Councilor Flynn, Commissioner Howard*

*Vice Chair Lachance* introduced an outline of a decision-making process for review and further refinement once working groups or the EDC, as a whole, develops initiatives or is presented with an initiative from City Council.

Office of Economic Development Update: *S. Clancy*

- The Customer Relationship Management tool (CRM) is fully functioning and being utilized to engage the business community in the Master Plan process.
- There is a lot of activity with the Public Art Review Committee as well as the Arts and Cultural Commission which may serve to support the Arts, Culture, and Enrichment working group

Chamber Collaborative Update – *B. VanCamp*

- 2026 Tourism Summit scheduled for February 11<sup>th</sup> from 8am-noon
- 2026 Economic Outlook scheduled for February 17<sup>th</sup> from 8am- 10am at the Atlantic Gril
- New Event: Hear & There, a weekend of music around the Seacoast is being heavily promoted by the Chamber
- The Chamber Public Policy committee is monitoring some problematic bills in Concord. One eliminates the Housing Champion program and associated funding (Portsmouth was a “housing champion” in the past). There is an open invitation to any EDC member who would like to be more involved with the Chamber’s Public Policy efforts.
