Thank you for selecting Hinckley Allen & Snyder, LLP ("the Firm") to represent the City of Portsmouth with respect to the McIntyre Project. This letter will confirm our discussion regarding our engagement and describe the basis on which the Firm will provide legal services to you.

Unless previously terminated, our representation of you in these matters will terminate upon our sending you our final statement for services rendered in the respective matters.

Fees and Costs

We have agreed our fees will be established and agreed to on a per task and assignment basis. For each task or assignment we will establish a scope of work, set a fee or fee range for that scope, and services will be performed on that basis. In no event will any monthly invoice exceed \$10,000 without the prior approval of the City.

Payment of Statements

Monthly invoices are rendered for work performed and expenses during the previous month. Payment is due promptly upon receipt of our statement. Any amounts not paid within 45 days will incur a late charge at the monthly rate of 1 percent. Unfortunately, we feel that we must tell all our clients that if it becomes necessary for us to file suit for the collection of our fees or disbursements, they are responsible for all our related costs and expenses, including reasonable attorneys' fees.
