This variance request will not impact the public interest as noted below:

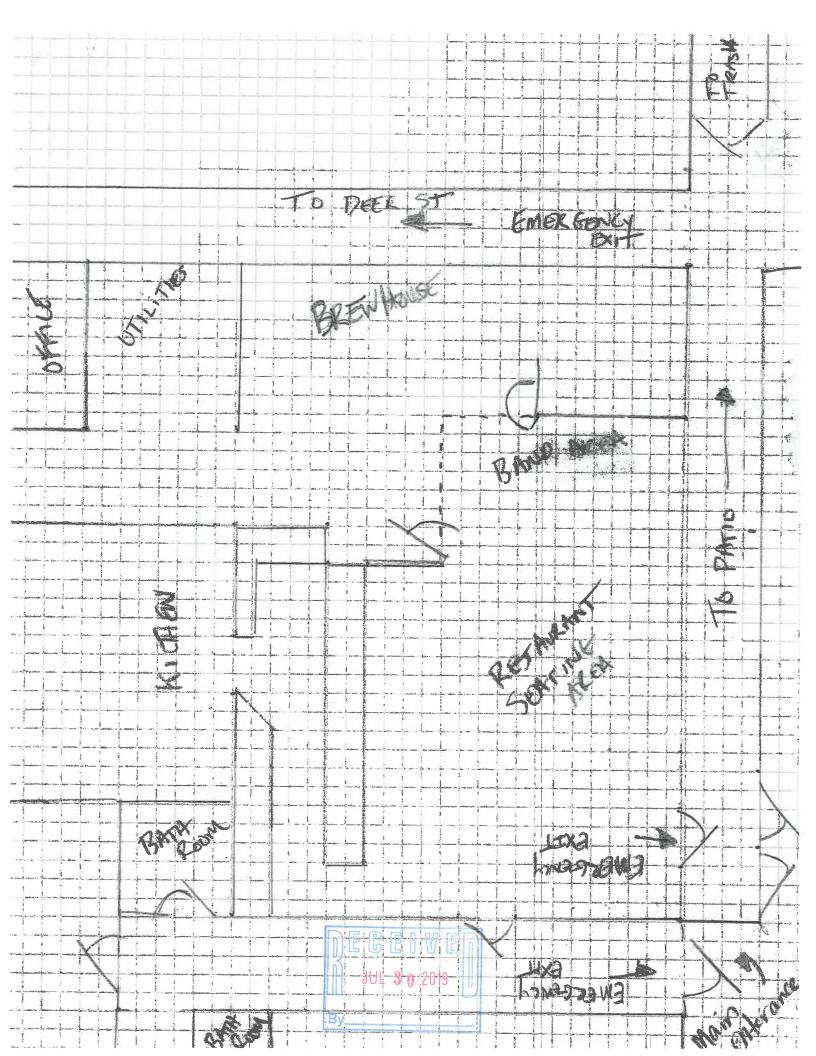
