To All Seasonal Boater Applicants:

Applications for the seasonal boat slips will be accepted at the City of Portsmouth's City Clerk's Office from November 25th, 2019 through January 2nd, 2020. Please note there will be no mailing of applications to individuals this year. Applications can be found on the City of Portsmouth's Website at www.cityofportsmouth.com/prescottpark and are due in the City Clerk's Office by Thursday January 2nd, 2020 at 4:30pm. There will be no exceptions.

Applications must be fully completed and signed for consideration & inclusion in the lottery to be held at 9:00AM Friday, January 3rd 2020 at the City Clerk's Office, City Hall.

As in the past, seasonal slips are first awarded to Portsmouth residents. **Please note that this means the vessel must be registered in the City Resident's name. If the boat is co-owned, one owner on the registration must be a City resident.** If there are any remaining slips available after the Portsmouth Resident drawing, a separate lottery will be held for non-residents. Notification will be sent out to all applicants after the lottery drawings have been completed as to whether you have drawn a seasonal boat slip or not.

Those awarded a slip through the lottery will receive a boater's packet containing paperwork that must be submitted with the full payment amount due at the time so specified in the packet.

Those who were not awarded a slip in the lottery will receive notification and will be retained on a waiting list in the order that the application was drawn in the lottery. Should any seasonal boat slips become available at a later date for any reason we will contact the individuals based on this list.

We also ask that you be sure to review the City's Dock Policies for 2020 (included with application on website) before submittal of your Seasonal Boaters Application so you are aware of the requirements for the seasonal slips.

POLICY FOR THE PRESCOTT PARK DOCKS
SUMMER 2020

1. No more than 12 "slips" or spaces at the Prescott Park Dock shall be available for seasonal rental.
2. Slip tenants shall execute a license agreement (for a specific vessel only) approved by the City Attorney setting forth the rules and regulations of the seasonal license. The license shall not be assignable or transferable to any other person or vessel and shall expressly prohibit alcohol use on the docks and shall address parking and waste issues.
3. Slip licensees shall pay **\$122 per boat foot** per season (from April 2 to November 1 of each year) for Portsmouth residents, fully payable in advance and non-refundable. A \$250/season Utility Access fee also applies to each slip.
4. Slips shall first be made available for seasonal rental to Portsmouth residents with the submission of applications by **January 2nd, 2020** and is for a term not to exceed one season with no right of renewal; the lottery, shall be held on January 3rd, 2020 to grant one year seasonal licenses only.
5. The lottery shall be organized and operated by a disinterested party chosen by the City.
6. All "slips" not rented for seasonal use shall continue to be available to the public on reasonable terms set by the City of Portsmouth at the City approved docking rates.
7. If all of the seasonal rentals are not filled by Portsmouth residents, non-residents are permitted to apply for a dock space in a separate lottery (following resident lottery), with higher seasonal rates \$150 per boat foot to be charged for such non-residents. A \$250/season Utility Access fee also applies to each slip. Non-residents are required to submit their application under the same deadlines as noted above and on the application.
8. A pro-ration of the seasonal use rates based on a daily basis is permitted for available designated seasonal use slips after June 30 through the end of the season (Nov 1).
9. The "boating season" and the term of the seasonal rental agreement is from April 2 to November 1 of each year.
10. Seasonal dock slips may not be used by other parties/boaters while the awarded seasonal boater is away.
11. No commercial boats are permitted to apply for a seasonal dock slip.
