







Work to be Completed in Coming Month


- Continue minor finish work at the Headworks Building
- Continue architectural, structural, mechanical process, HVAC, plumbing, and electrical construction in the Grit Building
- Continue minor finish mechanical and electrical work in the BAF Building
- Complete remaining minor installation work for stairs, railings and ladders in the BAF Building
- Continue startup of the BAF Building process and place the BAF in service
- Continue minor interior touch up painting in the BAF, Solids and Grit Buildings
- Continue integration of the BAF control system with the plant's SCADA system



Work to be Completed in Coming Month, Cont.

- Continue installation of the minor building finishes such as door hardware and signage in the BAF and Solids Buildings
- Continue minor electrical, HVAC and plumbing finish work in Solids Building
- Continue installation, check out, and startup of Gravity Thickener No. 2 mechanism and scum pumps
- Continue selective demolition in the existing Sludge Processing Building and Chlorine Contact Tank
- Continue structural repair and modifications to the new Operations/Lab Building
