The general public is discouraged from attending. Bid results are available as public records upon request. The Bid due date remains Tuesday, March 24, 2020 at 2:00 pm.

2. <u>Delivery of Bids:</u>

Bids will be received at the City of Portsmouth Department of Public Works (DPW) located at 680 Peverly Hill Road, Portsmouth, NH 03801. Please note the following regarding delivery of Bids:

Please use the northwest entrance identified on the enclosed map, and leave your Bid with the front desk.
- Mailed Bids will be accepted. Instructions for delivery personnel will be posted on the DPW facility door.
- If you have already submitted a Bid to the Purchasing Department at Portsmouth City Hall, please contact Ryan Flynn, City of Portsmouth Project Manager, at (603) 828-6325 so that arrangements can be made to have the Bid transferred to the DPW facility for the Bid Opening.

3. Bid Opening:

- Each Bidder is asked to send only one representative to the Bid Opening.
- Please be aware of and adhere to the current CDC guidelines for social distancing and sanitation while on Public Works property. The training room chairs and tables will be set up to provide adequate distance between all meeting attendees.
- 4. The City of Portsmouth intends to proceed with awarding the Agreement for this project following the Contract Times and dates outlined in the Bidding Requirements and Contract Documents.
