A total of five vehicles and one boat with trailer are up for bid: One 1994 Dodge Ram V-8 15 Passenger Van, one 2003 Crown Victoria, two 2004 Ford Crown Victoria, one 1998 Ford Explorer and one 1983 Sea Ox Boat with trailer.
