Questions/Answers

- Q1. Is the granular backfill item to be used as per typical detail on C-502?
- A1. Granular backfill is to be used as shown in typical pavement and gravel sections and typical road cross sections on sheet C-502.
- Q2. Where is the reclaimed base item to be used?
- A2. Reclaimed base item shall be used with existing paved areas that are to be rebuilt which include the existing Longmeadow Road cul-de-sac are and the sections of Lang Road where the new roadway alignment ties into the existing road.
- Q3. Curb is labeled on the plan and bid sheets as straight granite curb. There is a typical that also shows vertical granite curb. Is there any vertical?
- A3. There is no vertical granite curb to be constructed as part of this project.
- Q4. What are the limits of the cold planing?
- A4. The limits of cold planing are shown on sheet C-103 as the light hatched area on Longmeadow Road called out as "pavement to be resurfaced".
- Q5. Where is the 10 SY of 6" concrete sidewalk? Is this the raised island?
- A5. The 6" concrete sidewalk is the raised island on Lang Road.
- Q6. It appears that Item 632.02 is in there twice by mistake. Both have the same quantity.
- A6. The bid form has been revised to show all pavement symbols and words shall be 632.32. Item 632.02 has been removed from the bid form.
- Q7. The grades of the existing profile do not match. Which is correct?
- A7. Profiles on Sheets C-106, C-107 & C-108 have been revised to correctly label the existing and proposed elevations.

Additional Revisions:

- Bid Item 604.72 has been added to the Bid Form.
- Bid Item 615.0201 has been revised to be Item 615.01201 Traffic Signs, Type A.
- Route sign configurations on sheet C-103 and C-201 have been revised.
- Curbed island has been revised to avoid conflicting with an existing sewer manhole cover.

The plan set has been revised. The revised plan set is dated October 4, 2021.

The Bid form has been revised. The correct bid form is attached. Please disregard the original bid form.
